SECTION 6 — ACCIDENTAL RELEASE MEASURES

Do not allow solid to become airborne. Ventilate area. Gather up material in a pile (do not sweep). Place in a suitable container and dispose. Wash spill site after material pickup is complete. See Sections 8 and 13 for further information.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfates, thiosulfates and phosphates.

Deliquescent. Store in a cool, dry place within a Flinn Chem-SafTM bag. Do not breathe dust or fumes (P260). Use only in a hood or well-ventilated area (P271).
