# SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral and inhalation (Category 4). Harmful if swallowed or inhaled (H302+H332). Do not eat, drink or smoke when using this product (P270). Avoid breathing mist, vapors or spray (P261).
