SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 2). Highly flammable liquid and vapor (H225). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).



Hazard class: Skin corrosion or irritation (Category 2). Causes skin irritation (H315).



Hazard class: Sensitization, skin (Category 1). May cause an allergic skin reaction (H317). Avoid breathing mist, vapors or spray (P261).

Hazard class: Specific target organ toxicity, single exposure; respiratory tract irritation (Category 3). May cause respiratory irritation (H335).

SECTION 4 — FIRST AID MEASURES

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #3. Store with hydrocarbons, oils, esters and aldehydes. Store in a dedicated flammables cabinet. If a flammables cabinet is not available, store in Flinn Saf-Stor™ can. Do not store under inert atmosphere. Use only in a hood or well-ventilated area (P271). Keep cool (P235). Ground or bond container and receiving equipment (P240). Use explosion-proof electrical and ventilating equipment (P241).

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271).
