# SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 2). Highly flammable liquid and vapor (H225). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).



Hazard class: Skin corrosion or irritation (Category 2). Causes skin irritation (H315).

Hazard class: Sensitization, skin (Category 1). May cause an allergic skin reaction (H317). Avoid breathing mist, vapors or spray (P261).



Hazard class: Specific target organ toxicity, single exposure; respiratory tract irritation (Category 3). May cause respiratory irritation (H335).

#### SECTION 4 — FIRST AID MEASURES

Call a POISON CENTER or physician if you feel unwell (P312).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340).

**If in eyes:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do so. Continue rinsing.

**If on skin or hair:** Immediately remove all contaminated clothing. Rinse skin with water (P303+P361+P353). **If skin irritation or rash occurs:** Get medical advice or attention (P333+P313).

In case of fire: Use a tri-class dry chemical fire extinguisher (P370+P378).

# SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #3. Store with hydrocarbons, oils, esters and aldehydes.

Store in a dedicated flammables cabinet. If a flammables cabinet is not available, store in Flinn Saf-Stor<sup>TM</sup> can.

Do not store under inert atmosphere. Use only in a hood or well-ventilated area (P271). Keep cool (P235). Ground or bond container and receiving equipment (P240). Use explosion-proof electrical and ventilating equipment (P241).

# SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271).
