Flinn Suggested Chemical Storage Pattern: Inorganic #6. Store with chlorates, bromates, iodates, chlorites, perchloric acid, and peroxides.

Deliquescent. Changes color when exposed to light. Store in a cool, dry place within a Flinn Chem-SafTM bag. Keep away from combustible materials (P220). Take any precautions to avoid mixing with combustibles (P221).
