This product contains Ethyl Benzene. A draft report on a study conducted by the National Toxicology program states that lifetime inhalation exposure of rats and mice to concentrations of Ethyl Benzene (750 ppm) resulted in increases in certain types of cancer, including kidney tumors in rats and lung and liver tumors in mice. These effects were not observed in animals exposed to lower concentration of Ethyl Benzene (75 ppm or 250 ppm). The draft report does

not address the relevance of these results to humans.

The International Agency for Research on Cancer has evaluated ethylbenzene and classified it as a possible human carcinogen (Group 2B) based on sufficient evidence for carcinogenicity in experimental animals, but inadequate

evidence for cancer in exposed humans.
