SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Skin and serious eye damage, corrosion or irritation (Category 2, 2A). Causes skin and serious eye irritation (H315+H319).

SECTION 4 — FIRST AID MEASURES

Get medical advice or attention (P313). **If inhaled:** Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340). **If in eyes:** Rinse cautiously with water for several minutes.
