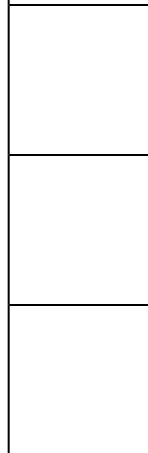

SECTION 2 — HAZARDS IDENTIFICATION
